FAWL Thinks Pink!

SPBC FAWL held its **Fifth Annual FAWL Thinks Pink Luncheon** on October 10,
2013 at the Boca Grove Country Club.
The key note speakers, twin sisters Dani
Mofshin and Cari Kutno, shared their
moving and personal stories of, together,
undergoing double mastectomies and
complete hysterectomies after discovering
that they have a deleterious mutation of the
BRCA 1 gene. When working properly,
both the BRCA 1 and the BRCA 2 genes
produce proteins vital to tumor
suppression. The deleterious mutation of
the BRCA 1 gene that Ms. Mofshin and Ms.

Kutno both inherited greatly increased their risk of developing breast, ovarian, and other forms of cancer. Without the mutation, their risk for breast cancer and ovarian cancer would have been approximately 12% and 1.4%, respectively. With the mutation, their risk increased to 55% to 65% for breast cancer and 39% for ovarian cancer. Ms. Mofshin and Ms. Kutno decided to undergo genetic testing for this gene mutation after their mother won her own battle with breast cancer. SPBC FAWL raised \$1,000 at the luncheon, which was donated to Lynn Cancer Institute.

A BRIEF HISTORY OF SPBC FAWL

Most of the members of today's SPBC FAWL chapter, including me, were not around when the chapter was founded back in early 2004. Soon after the formation team organized, they fortunately had the

foresight to name a chapter historian to document some of the fledgling chapter's milestone events – the first monthly lunch, the first new member reception, the first judicial reception, the first holiday party, etc.

Although the scrapbook history

of SPBC FAWL ended a few years back, many of our current members, including me, were first-hand witnesses to the growth and development of this amazing organization over the past decade.

The first president of SPBC FAWL – and the only one who served a two-year term – was Lisa Peraza. Lisa and the other chapter founders – including current members Robin Bresky

(SPBC President 2007-2008), Tanya McConnell (SPBC President 2010-2011) and Tammy Saltzman (SPBC Chapter Liaison 2013-2014) – saw the need for a local FAWL chapter to serve the needs of the women lawyers practicing in Boca Raton and Delray Beach. At the time, the only

other option for women practicing in these areas was to join Palm Beach County FAWL or Broward FAWL, both of which were inconveniently located outside of South Palm Beach County.

I joined SPBC FAWL in 2006 after attending a new member reception at the Evelyn Baker Gallery. Although I only knew a few people in the chapter at the time, I quickly recognized that this was a phenomenal group of women and that I

needed them in my professional and personal networks!

When I joined SPBC FAWL, Rochelle (Shelly) Kerner was the chapter president, and our lunches were held at Gulf Coast Seafood restaurant (now Hooters – oy vey!). A fun

trivia fact to know is that Shelly was the only chapter president who never served as a president-elect. This was because Maria Sachs, who was slated to be president of SPBC FAWL for the 2006-2007 term, was elected state senator!

Unfortunately, Maria's position required her to resign from SPBC FAWL's board of directors, but that has never stopped Sen. Sachs from being an active member of our chapter who often appears as one of our favorite luncheon speakers.

During Shelly's tenure, SPBC FAWL hosted its first judicial reception, honoring retiring probate Judge Gary Vonhof. Over 100 lawyers and judges from all over South Palm

Beach County and beyond attended that event, and it was an overwhelming success. That first judicial reception put our chapter on the community's radar, and the chapter immediately decided to make the judicial reception an annual highlight of our programming year.

In 2007, Robin Bresky took over as chapter president and, despite her diminutive size, Robin was (and still is!) a

powerhouse of leadership. We are so proud that Robin is currently serving as President of the South Palm Beach County Bar Association and the President Elect of State FAWL. During her tenure, Robin added an annual

holiday party to SPBC FAWL's calendar of events; our first one – and several more thereafter – were hosted by and held at the offices of SPBC FAWL's long-standing, loyal, and generous sponsor, Sabadell Bank (then known as Mellon United). We had some wonderful parties in the bank's lobby, and I can say without qualification that SPBC FAWL would never have been able to attain the success it has without the continued support

of Bud Osborne, Donn Londeree, and the entire team at Sabadell.

By the time Holly O'Neill took the helm as president for the 2008-2009 term, SPBC FAWL was running like a well-oiled machine. We had our calendars full with monthly membership luncheons, the new member reception in September, the holiday party in December and the judicial reception in February.



Membership was steadily increasing, and the board of directors was in overdrive planning events and new ways to showcase the chapter and reach out to the community.

When I took over as president in 2009, my friend Mindy Stein (SPBC President 2011-2012), who was then the chapter liaison to State FAWL, decided that SPBC FAWL (an organization "for" women) needed to spearhead its own breast cancer awareness and fundraising event; and with

that, our first annual "FAWL Thinks Pink" was born. The inaugural event was unlike the dignified luncheons and raffles that we have had in the past few years. Instead, we decided that all the members would donate costume jewelry and accessories which would be sold at our "Unique Boutique" during the lunch. Needless to say, it was a lot of fun but a lot of work, so we decided to scale it back and simplify. We

When Tanya McConnell took over as chapter president in 2010, she championed numerous civic organizations and encouraged the chapter to become involved with The Haven and Habitat for Humanity. Tanya's extensive knowledge of and history living in Boca Raton proved invaluable in countless ways. Tanya led us with an unprecedented level of collegiality, and she made

certain our board appropriately acknowledged our sponsors and continued to serve as an exemplary voluntary bar organization.

Mindy Stein became our

president in 2011, and she began her term with our first ever board retreat where we discussed goals and programming ideas for the upcoming year.

One of our most exciting programs that year was a program to educate high school seniors about the legal implications of turning 18 and becoming an adult. The program was implemented using a power point presentation authored by The Florida Bar and entitled, "Now You are an Adult". I

personally volunteered to coordinate and administer the program for two years and, as a result of our chapter's hard work, this became SPBC FAWL's signature program – "Educating Tomorrow's



Adults" – which was honored in 2013 as Outstanding Public Service Program, beating out every other public service program organized by other FAWL chapters throughout the state. Way to go, SPBC FAWL!

Angelina Namia brought a new layer of success to the chapter when she became president in 2013. Angelina's business savvy helped to expand the reach of corporate sponsorships and, as a result of her efforts, SPBC FAWL now has multiple annual sponsors, lunch sponsors, event

sponsors, and more judicial reception sponsors than ever in the past.

Laurie Thompson has continued to take the lessons learned from her predecessors to help SPBC FAWL to newer and greater

heights. When Leorah Greenman takes over in 2014, she will have big shoes to fill, that is for sure! But knowing Leorah as I do and watching her grow as a chapter leader, lawyer, and mother, I am sure that it will be smooth sailing for SPBC FAWL into the next decade!



FORECLOSURE SURVIVOR... LIFE AFTER THE STORM

As we move past Thanksgiving, and the New Year is around the corner, it is a time that many of us focus on the things in our life for which we are most grateful. In South Florida, we all breathe a sigh of relief that we have gotten through another Hurricane Season unscathed, and I think about the unique bond that we share as "Hurricane Survivors". We have learned many lessons over the years in preparing for these dangerous storms and their aftermath.

I moved to Boca Raton in 1992, just three days before Hurricane Andrew, and learned a lot that week...about hurricanes, about life in Florida, and about the need to be prepared with a planbefore, during, and after the storm.

In a way we are lucky, because unlike other natural disasters, such as earthquakes, hurricanes take time to develop and they give us warning about their impending assault. This offers the unique ability to plan, prepare, and protect ourselves, our homes, and our loved ones to the best of our abilities. In fact, experts suggest that it makes sense to prepare ourselves months before the storm warning is anywhere on the radar. We are urged to make a plan, and review the plan with family and experts, and finally to stay alert and advised on weather updates and warnings. There is also a "to do" list for during and after the storm once it has arrived.

There are many similarities between preparing for a hurricane and dealing with the unfortunate situation of being "upside down" in a home and/or not being able to pay the mortgage. Similar to hurricanes, a foreclosure takes time to develop, and there is plenty of warning that trouble may be on the horizon. In addition, planning and preparing can make all the difference between disaster and a more positive outcome. The strategy is to hope for the best, but plan for the worst.

When people are faced with the difficult decision of whether to stay in their home and struggle to make payments that are above their heads, or let the home go, by either a short sale or foreclosure, the choice is often painful. It may be difficult to sort through the field of information in order to make an informed decision based upon real options. Even under the best of circumstances, moving is stressful. When people are struggling with the options of short sale or foreclosure, the emotions and the stress can be overwhelming.

If you have a client whose home might be in jeopardy, the client will need a good team of professionals who will help them evaluate their options to reduce their debt-load, such as a loan modification, refinance, or restructuring their debt.

After the client reviews their options, if they find that they just cannot afford their home, the client will need to explore their evacuation plan--the sale of their home. Is there enough equity in the home to go for a traditional sale, or is the best option a short sale or foreclosure? A short sale, in the hands of responsible and knowledgeable professionals offers a lot more control and predictability then letting the house go into foreclosure, as well as a quicker and easier recovery of finances and credit.

The next step is to determine the amount of housing expenses that will be affordable in order for the client to move on, and to find a situation that meets his/her needs. Just as with a hurricane evacuation, there must be a plan for pets, special needs, and an effort to make their new home as affordable, comfortable and secure as possible.

Whether your client is comfortable in a home that has lost substantial equity, struggling to keep their home and pay their mortgage, or trying to find a way to move into a new home, they are all trying to make sense of the new rules and navigate their way through the constant changes. They are looking for answers...a way to re-create the security they previously felt, even as the moving target in the financial world continues to shift. We may not have control over the global changes that occur in Wall Street, any more then we have control over a hurricane swirling around in the Atlantic Ocean making its way towards the coast. Fortunately, there are always options, and it is more important than ever to help our clients explore what opportunities might be out there for them.

Either way, you know you have helped your client weather the storm so that they are prepared for whatever Mother Nature brings their way.

As the New Year approaches, let's hope that we all head into clear skies and cool breezes. I wish everyone a sunny and prosperous 2014, and I look forward to getting to know you better and working with you as part of my team.
