## HURRICANE IAN: COULD THIS BE THE COLLAPSE OF THE FLORIDA PROPERTY INSURANCE MARKET?

Just over thirty-years ago, Hurricane Andrew hit Florida. The massive storm caused \$27.3 billion in property damage, forced at least sixteen insurance companies into insolvency, and resulted in numerous changes to Florida laws and building codes. Now, thirty-years later, Hurricane Ian has decimated the southwest coast of Florida and caused damage as far south as Cooper City and as far north as New Smyrna Beach. With Florida's property insurance market already reeling prior to Hurricane Ian's landfall, the future of the market is uncertain, especially with an estimated \$50 billion in property damage caused by the storm.

Earlier this year, the Florida Legislature passed a number of laws in an attempt to save the ailing property insurance market. Most of these laws have been cited by experts as not going far enough to help homeowners, and some of the new statutes are already being challenged. It is likely that when the Legislature reconvenes, they will have to re-address the property insurance market, this time post-Hurricane Ian. For now, a brief review of the Legislature's latest attempts to assist the property insurance market, which became effective earlier this year, is important.

### **Reporting Times**

Hurricane or tropical storm damage is not always obvious and can take some time to surface before it is noticed by homeowners. Previously, Floridians had up to three years from the date the National Oceanic and Atmospheric Administration reported the hurricane to have made landfall to file a claim with their insurance company. In 2021, the Legislature limited that time frame to only two years.

#### **Building Code Changes**

Some of the most important legislative changes Hurricane Andrew made in Florida were regarding building codes. Post-Hurricane Andrew, the Legislature required dwellings to be built with the idea of withstanding the wind-gusts associated with our hurricane seasons. In a recent Florida Legislative Special Session, some of those building code requirements were removed in an attempt to assist the property insurance market.

Specifically, the code post-Hurricane Andrew required that if roof damage was beyond 25% of the roof system, an entire roof replacement was required.

This requirement was put into place likely to ensure the structural integrity of a roof in the event of a catastrophic storm like Hurricane Andrew. In 2021, the legislature amended this requirement to state that if the property's roof was in compliance with the 2007 or later version of the Florida Building Code and requires repair of 25% or more of the system, only the damaged portions need to comply with newer versions of the Florida Building Code. From a cursory review, this change could have a terrible ripple effect, leaving a homeowner's homes in unsafe conditions to withstand a catastrophic storm.

#### "RAP" Program

As a result of the mass of insurance company insolvencies seen after Hurricane Andrew, the Legislature created the Florida Hurricane Catastrophe Fund, or "Cat Fund," to provide reinsurance for insurance companies. Reinsurance is essentially insurance for insurance, to cover losses they may not be able to in the event of a mass catastrophe. Due to Florida's heightened frequency of natural disasters, costs of reinsurance to insurance companies can be high, and has been cited by insurance companies as a reason for rate increases.

Within recent years, additional reinsurance for insurers has become costly, and a reason for some insurers to pull business out of Florida or become insolvent. In order to assist insurance companies and prevent additional insolvencies, the Legislature recently enacted the Reinsurance to Assist Policyholders ("RAP") program. The RAP program's purpose was to provide assistance to both insurance companies, via financial assistance to assist with obtaining reinsurance, and homeowners, via rate decreases. However, experts and data seem to indicate the RAP program may not have gone far enough.

The RAP program was created using taxpayer funds to provide financial assistance to insurance companies seeking reinsurance. The program became effective around July 1, 2022, and as a requirement to utilize the program, insurance companies had to provide rate decreases to policyholders. However, rather than immense savings passed to homeowners, most insurance companies have filed for mere 1-2% rate decreases. Considering the average cost of property insurance in Florida is now around \$3,600, and these same companies have recently hiked their rates by at least 30%, these decreases will likely fail to provide any relief to homeowners.

#### 2021 Statutory Changes

The Florida Legislature's 2021 statutory changes are still resulting in confusion throughout districts, especially in the case of assignment of benefits. Prior to the statutes' enactment, the Florida Supreme Court denied certiorari on the issue of whether restrictions on assignment of benefits were valid. The Court cited the 2021 statutes would answer this question, but thus far, we've seen no answers.

In Restoration 1 of Port St. Lucie v. Ark Royal Insurance Company, the Fourth District Court of Appeals admittedly conflicted with the Fifth District Court of Appeals on the issue, finding restrictions on assignments requiring the consent of all insureds, including the mortgagee, are permissible. On the other hand, the Fifth District Court of Appeals determined in Security First Insurance Company v. Florida Office of Insurance Regulation that any restriction on an assignment of benefits in an insurance policy is impermissible.



The 2021 statutes have yet to be put through rigorous judicial interpretation and there are still a number of questions to be answered, such as whether a pre-suit settlement offer can be waived if it is impossible to calculate, or the many conflicts with pre-existing proposal for settlement statutes. These latest statutes resulting from the 2022-D special session will likely result in additional confusion.

\*\*This article is current as of November 8, 2022, but the law continues to change as the Legislature battles to find a solution to the Florida property insurance crisis.

## CHANGES IN CONDOMINIUM REAL ESTATE TRANSACTIONS

Any Buyer or Seller of a condominium unit, or anyone representing a Buyer or Seller of a condominium property should be aware of the changes/new laws going into effect March 2023, relating to the buy/sell transaction.

As you may already know the Seller of condominium property is obligated to provide to the Buyer, the Condominium Governance Form per Florida Statute 718, (quite overlooked in the industry!!) and copies of the following documents: CURRENT COPY OF THE DECLARATION OF CONDOMINIUM, ARTICLES OF INCORPORATION, BYLAWS AND RULES OF THE ASSOCIATION, AND A COPY OF THE MOST RECENT YEAR-END FINANCIAL INFORMATION AND FREQUENTLY ASKED QUESTIONS AND ANSWERS DOCUMENT IF SO REQUESTED IN WRITING. The consequence to the Seller not delivering these items as soon as possible may be termination of Contract by the Buyer, as it is the Buyer's right to cancel the Contract within 3 days of receipt of these documents.

Accordingly, when representing the Seller of condominium property, we recommend having the Seller spend the money to obtain the most current and complete set of these documents directly from the association to provide to the Buyer within one day of the Effective Date (full execution) of the Contract.

When representing а Buyer of condominium property, we encourage Buyers to take the time to read these documents (or to have an attorney review and explain) them as these documents govern the use, restrictions, expectations, and other important issues of buying and living in that condominium community.

ADDITIONS/CHANGES: The Florida Bar and Florida Realtors are coming out with changes to the FARBAR Standard form of Condominium Rider form reflecting the changes in Florida Statute 718, due to the need to maintain the structural integrity and soundness of a condominium building as paramount importance to the health safety and welfare of its occupants, as a result of the catastrophic collapse of the Surfside Condominium in Miami Beach.

The following additions to the Condominium Rider form are in part as follows:

- MILESTONE INSPECTION REPORT SUMMARY: Pursuant to Section 718.503(2)(a) (5), F.S., Buyer who has entered into this Contract is entitled, at Seller's expense, to receive from Seller, before the sale of the Property, a copy of the inspector-prepared summary of the milestone inspection report, as described in Sections 553.899 and 718.301(4)(p), Florida Statutes, if (1) applicable and (2) the summary has been submitted to the Association.
- STRUCTURAL INTEGRITY RESERVE STUDY: Pursuant to Section 718.503(2)(a)(6), F.S., Buyer who has entered into this Contract is entitled, at Seller's expense, to receive from Seller, before the sale of the Property, a copy of the Association's most recent structural integrity reserve study or a statement that the Association has not completed a structural integrity reserve study.

We are recommending that Sellers obtain copies of the above additional documents from their associations in anticipation of the sale of their condominium property. We also recommend Buyers specifically request these documents for their review and approval within the Buyer's Inspection Period in order to make an informed decision of whether to continue with the transaction or terminate.
